ORDER:

In the G.Os. first and second read above, orders were issued regarding payment of subsistance allowance at the rate of Rs. 200/- to each freed bonded labourer at the time of release.

- 2. As the present quantum of subsistance allowance is considered to be inadequate, Government hereby enhance the rate of subsistance allowance from Rs. 200 to Rs. 500 to each of the released bonded labourers.
 - 3. An amount of Rs. 200 will be debited to,-
 - "288 Social Secrurity and Welfare—C. Welfare of Scheduled Castes, Scheduled Tribes and other Backward Classes—M.H. 05—Welfare of Scheduled Castes—F. Other Social Welfare Schemes Monetary Reiter and legal aid to victims of atrocities on Scheduled Castes—090—Grants—in-Aid.
- 4. The additional amount of Rs. 300 per bonded labourer shall be met from the grants released from the State share for rehabilitation of bonded labourers under the Centrally Sponsored Scheme under the following head of account:

Support Schemes."

- 5. The total amount of Rs. 500 should be paid immediately after the release of the bonded labourer, without any dealy so that he is able to subsist until further rehabilitation measures are implemented.
