ORDER:

It has come to the notice of the Government that, in Mahabubnagar district, large number of labour are being engaged to work on worksites across the country on contract basis. Quite often the labour are lured into the contract by advancing huge amounts to the labour, who have to work to repay the loans. There are instances where such labour are forced to work at wages less than the minimum wages. Understandably, the system is perpetuated by a network of middle men locally called "gumpu mestris"

- 2) A number of poverty alleviation programmes are being implemented by the Government which can effectively rescue labourers from the vicious cycle of poverty and indebtedness. But yet large No. of labour are still becoming victims of the exploitative practice. National Rural Employment Guarantee Act has immense potential to address this challenge.
- 3) In order to ensure that poor labour of Mahabubnagar are not forced into bonded labour by the "gumpu mestris", Government here by direct the District Collector, Mahabubnagar to take up certain urgent measures as detailed below.
 - An intensive campaign shall be launched in the district to bring on record all instances of labour inducted into the exploitative distress migration by the "gumpu mestris", in 2-3 weeks from now.
 - ii. Steps as per the law shall be taken to free the labour from the bondage, immediately. Since group mestries and forced labour is within the definition of bonded labour, District Collector is requested to enforce Law and take stringent and deterrent criminal action against the perpetrators and release bonded labour.
 - iii. The freed labour shall be given work in their own villages under NREGS, without limiting to 100 days per family. The labour shall be facilitated to earn wages from NREGS on continuous basis, so that they are not vulnerable to become bonded labour once again.

The women of the freed labour families who are still outside the fold of SHGs shall be organized into SHGs and given access to credit under Pavalavaddi program.

In the orders cited above, Government have given a special dispensation to the freed Bonded Labour in Mahboobnagar district so as to provide them continuous work under MGNREGA.

- The International Justice Mission (IJM) a NGO, working on the issues of identification, release and rehabilitation of the bonded labour in Chittoor, East Godavarl, Guntur and Nellore Districts, requested that a greater coordination with the district administration and provision of the benefits provided through MGNREGA as has been done in Mahboobnagar would go a long way in improving compliance of the legal provisions of the Bonded Labour abolition Act.
- After careful consideration, it has been decided to:

a) AP NGO Alliance (APNA) working in MGNREGA may be requested to undertake the above work in their respective areas of operation.

- b) Request the District Collectors to have an Immediate meeting with the organizations like IJM working on the issue of bonded labour and workout modalities for identification, release and rehabilitation of the bonded labour, PD DRDA should assist the District Collectors
- c) To extend the benefits given under the G.O. cited above to all the districts for the freed bonded labour.
- Action taken for the pursuance of these Instructions may be intimated on a monthly basis by the PDs DRDA.
