

## NOTIFICATION

In exercise of powers conferred by sub-section(1) of Section 13 of the Bonded Labour System (Abolition) Act, 1976 read with sub-section (2) thereof, and suppression of All previous orders issued in this regard, the Governor of Bihar is pleased to constitute District level vigilance Committees for all district of the State following manner :—

| 4. Deputy Development Commissioner and/ or in his absence the District Development Officer   | Member           |
| 5. Assistant Director, Social Security   | Member Secretary |
| 6. Managing Director, District Rural Development Agency (Nominated by the State Govt, in official Capacity)  | Member           |
| 7. One representative of Central Co-operative Bank or Rural Bank or Commercial Bank to be nominated by District Magistrate                           | Member           |

2. The vigilance committee shall regulate its own procedure and Secretarial assistance, as may be necessary, shall be provided by the District Magistrate;
3. The Functions of the vigilance Committee shall be as follows:-
  - (a) to advise the District Magistrate as to the efforts, made and action taken, to ensure that the provision of the aforesaid Act are properly implemented;
  - (b) to provide for the economic and social rehabilitation of the freed bonded labourers;
  - (c) to co-ordinate the functions of rural Banks, Co-operative Banks and Commercial Banks, as may be necessary, with a view to canalising adequate credit facilities to the freed bonded labourers;
  - (d) to keep and eye on the number of cases filed and disposed of in regard to the offences under this Act,
  - (e) to make a Survey as to whether there is any offence of which cognisance ought to be taken under this Act,
  - (f) to defend any suit instituted against a freed bonded labourer or a member of his family or any other person dependent on him or the recovery of the whole or part of any bonded debt or any other debt which is claimed by such person to be bonded debt;

4. The vigilance committee shall meet as often as necessary but at least once in two months for the discharge of its functions. The Assistant director, Social Security (District Headquarter shall be convenor of the District level Vigilance committee.
