Dear Sh. Srivastava,

This is regarding Writ Petition (Civil) No. 3922 /1985 filed by Public Union for Civil Liberties Vs State of Tamilnadu and Others before the Hon'ble Supreme Court. The Hon'ble Court in its Order dated 1.10.2010 has made the following observations:-

"It appears from the Note submitted by the Amicus Curie that the States/Union Territories are receiving a sum of Rupees two Lakhs per District per three years. We have requested the Solicitor General to assist the Court in submitting the date as to the amount, which the Centre is releasing to the States/Union Territories and whether the States/Union Territories are in fact using the amount for which they are released."

I would like to draw your attention to the fact that Central Assistance amounting to Rs. 18.00 lakh for conducting survey of bonded labour was provided to State Government of Delhi in the year 2004-2005 but survey reports and utilization certificates in respect of the survey conducted has not been received from the State Government. In this connection the State Government was requested to submit the same vide this Ministry's letter of even no. 9.11.2010 and DO letter from DGLW dated 1.12.2010. (Copy enclosed)

Writ petition came up for hearing on 16.12.2010 and the Hon'ble Court has directed the Central Government to procure utilization certificates and survey reports from the State Governments and file a consolidated affidavit before the Court.

In view of the directions of the Hon'ble Court, I shall request you to arrange to forward Survey Report and Utilization Certificates immediately latest by 10.01.2011 so that the status could be incorporated in the affidavit to be filed before the Hon'ble Court. Since the matter is urgent, this may please be accorded **Top Priority**.
