Order:-

In the G.O. read above, orders were issued for constitution of the State level Screening Committee, with the Chief Secretary to Government as Chairman, for the Identification, Release and Rehabilitation of Bonded Labour. During the course of the meeting of the State Level Screening Committee, held by Chief Secretary on 30.11.2004, it has been decided to constitute a Committee with the District Collectors of Hyderabad and Rangareddy Districts for taking up a Survey for identification, Release and Rehabilitation of Bonded Labour and Child Labour in Hyderabad and Rangareddy Districts with the following members:

2. The Non-Governmental Organisation representatives shall be nominated by the District Collectors of Hyderabad and Rangareddy Districts.

3. Terms of References:

- i) Identification of all Child Labour and Bonded Labour cases, including Child Bonded Labour, in Hyderabad and Rangareddy Districts.
- ii) To work out Plan of Action for identification of Child Labour and Bonded Labour by involving the existing Mandal level and District Level Vigilance Committees, formed under the Bonded Labour System (Abolition) Act, 1976 and launch coordinated above with assistance of NGO's.
- iii) To take up rehabilitation measures for identified Child labour and Bonded Labour.
- iv) To review all previous cases of rehabilitation of freed Bonded Labour and undertake a study on the present economic and social status of freed Bonded Labourers and recommended under measure for total rehabilitation of freed Bonded Labour limits.
- v) To recommend to Government may further measures that are required to be taken for total elimination of Bonded labour system and on issues concerning Child Labour, and no report to Government on regular basis on the progress

made on identification, Release and Rehabilitation of Child Labour and Bonded Labour.

- vi) To build up Data-Base System on Computer on Child Labour and Bonded Labour for regular follow-up action, and also build up system to review on regular basis the prosecution cases under Bonded Labour System (Abolition) Act, 1976.

4. In this regard, Principal Secretary, Social Welfare Department, will review the progress of the Committee on regular basis, in consultation with the Principal Secretary, School Education Department and the Principal Secretary, Labour, Employment, Training & Factories Department.
